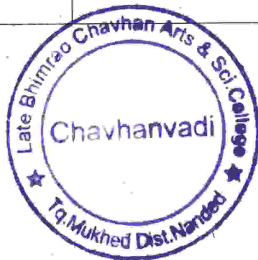
Declaration under Right to Information Statutory Declaration on RTI Act.

The Right to Information Act, 2005 (22 of 2005) has been enacted by the Parliament and has come into force from 15 June 2005. This Act provides for right to information for citizens to secure access to information under the control of public authorities in order to promote transparency and accountability in the working of every public authority. According to UGC guidelines all Universities and colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled or substantially financed directly or indirectly by funds provided by the Government shall come within the purview of public Authority under this Act, Since **Vasant Shikshan Prasarak Mandal's Late Bhimrao chavhan Arts & Sci. college Chavhanvadi (Barhali) Tq. Mukhed Dist. Nanded -431715 (Maharashtra)** is Grant in Aid category, Section 4 (1) (b) of RTI Act 2005 is applicable for college. The statutory declaration is displayed on college website.
